- Describes who or how someone is speaking.
- Comes before or after dialogue.

- Exclaimed.
- Growled.
- Shouted.
- Screamed.
- Directed.
- Explained.
- \* Repeated.
- \* Sniffed.
- Interrupted.

Generally considered
Weak writing.
Dialog or beat
should provide the context.

- "Sam!" I exclaim.
- "You dirty rat," he growled.
- "Get back here!" Larry shouted.
- "He's got a gun!" she screamed.
- "Go sit over there," Mr. Jones directed.
- "Let me go over this again," I repeated.
- "His mother is trailer trash," she sniffed.
- "I'm sorry—"
- "So am I," he interrupted.

Don't use a tag on every line if there are only two people talking.

## Descriptive Beat

- \* A beat is an action performed by the character before, after, or breaking up dialogue.
- \* Example: "Could I have a Coke?" Diane smiled at the waitress.
  - Let's the reader know who's speaking.
  - Enriches the scene.
  - Vary the pace of the dialogue.
  - Allows reader to visualize events.

## Descriptive Beat

#### Be selective.

- Should move the story.
- Add to the character.
- Offer motivation.
- Add to setting.

"The" is the only definite article in the English language.


It refers to a specific noun.

# Speech dysfunction

Self-handicapping.

The witness would love to be of help to you, but for some reason they cannot give a good description.

Time Factor.

For time to interview and complete sketch.

Facts are inconsistent.

- Quasimodo effect.
- Absence/Excessive detail.

Given the situation, there is either too much information or too little information.

- Reversal of Detail.
- Rehearsed and/or Memorized Statements.

Description sounds rehearsed. If you stop someone part way through the description, they have to start over from the beginning.

- Revisit Topic (TEST).
- Migrate to Safe Topic.

Witness wants to talk about other things rather than the description

Win the Officer Over.

Witness tries to win the approval of the officer through flattering statements.

Referral System.

Found with multiple witnesses.

Denial timing.

A deceptive suspect may not immediately deny the link to crime.

Seek Personal Attention.

Witness asks questions and seems to be gaining a lot of gratification from the attention.


